Sua obra constitui, como bem acentua Evaldo Vieira, na Conclusão, uma tentativa de sistematização ideológica dos princípios de uma revolução conservadora, entendida como uma "revolução burguesa retardada". Dentro desse ideário, o "Estado Corporativo é a essência deste projeto de contrarrevolução", já que Oliveira Vianna rejeita a transformação social, limitando-se a um projeto de reformas para evitar mudanças estruturais. Seus escritos são uma resposta à Revolução de 1930, que leva a uma crise de hegemonia, somente resolvida após o Golpe de Estado de 1937, dado por Getúlio Vargas. O que Oliveira Vianna pretende é a transformação da classe dirigente em classe dominante.
