It also includes coverage of important cases such as the House of Lords decision in *Yeoman v Cobbe*, *Dallah Real Estate v Pakistan Ministry of Religious Affairs* and those such as the Scottish decision in *City Inns* which demonstrate an on-going confusion and uncertainty in the analysis and application of these doctrines.
